2017 ANNUAL REPORT

The past year proved to be an active with efforts targeting the strategic areas of the HOA. See the side bar for key accomplishments.

The January annual meeting included reviews of accomplishments, finances, and social committee events. Two major in-progress projects, member roster development and the neighborhood watch program, were discussed. The meeting was attended by 24 members, representing 17 properties. Attendees offered input in development of the HOA vision, mission, and value statements, as well as approaches regarding the use of our three common areas.

Mike Ancona and Rick King were elected to the HOA board. Due to much interest in helping our neighborhood be even better, the Board in 2017 is adding ad hoc, non-voting members for one year as an initial trial period.

Financial Summary

The HOA had a 2016 revenue of \$13,576.00, all from member dues. Expenses came to \$14,567.43 resulting in an operating loss of \$990.73. As with the loss in 2015, the 2016 loss was funded from reserves. Grounds maintenance and repair constituted 84% of 2016 expense. The board plans to restructure common area maintenance schedules in order to reduce expenditures and improve appearance.
